High Interest, High Influence

These individuals include instructors and course creators contributing course material to the website. These are the providers of learning content. Need to be involved in designing/testing the website and communicating with developers

High Interest, Low Influence

These individuals include the **support** and **customer service** teams. These people work with users of the website to allow them to access the website. This group needs to be kept up through updates and documentation for the website.

Low Interest, High Influence

These individuals include **investors** and **sponsors** of the website. These individuals give funding and expect growth of the site and a return on their investment. They should be kept informed with progress reports and metrics as the site goes through its stages from creation to deployment to afterwards and beyond.

High Interest, Medium Influence

These individuals include **students** and **learners** utilizing the website. They are the primary users of the site who are looking for learning tools to improve their learning experience through audio, visual, doing and reading/writing. They can be involved through testing, feedback surveys and with a focus on website design and user accessibility

Medium Interest, High Influence


